

REPL bagged infrastructure consultancy projects in Andhra Pradesh and Odisha

New Delhi: Rudrabhishek Enterprises Ltd. (REPL), a Delhi-based infrastructure consultant, has bagged two important infrastructure development projects in Andhra Pradesh and Odisha. The Odisha Mineral Bearing Areas Development Corporation (OMBADC) has appointed REPL to provide consultancy and prepare Detailed Project Report (DPR) for Development of Education Infrastructure for 93 schools in Sundargarh district while the Andhra Pradesh Medical Services & Infrastructure Development Corporation (APMSIDC) has appointed the firm for rendering Architectural and Engineering services for new medical college at Madanapalli in Chittoor District of Andhra Pradesh.

For the development of education infrastructure project, REPL will prepare the comprehensive design and development plan for each school. It includes survey and developing project plan, comprehensive Architectural, structural and MEP services designs, and DPRs as per the OPWD Codes with cost estimates. The estimated cost for developing each school is INR 1.5cr. Each school will be designed as eco-friendly to limit the direct and indirect impact on environment and give a healthy indoor environment.

While working as a consultant for the Medical College project in Andhra Pradesh, it will provide master plan for the project area of 73 acres, comprehensive Designing (Architecture, Structure, MEP, HVAC, etc) with elevations, infrastructure developments plan with landscaping, BIM implementation, bid process management, construction supervision and other related work till the project delivery. The estimated value of the civil work for the medical college project along with a 500 bedded Hospital facility at Madanapalli is INR 250 Crores. It is expected that the project will get completed in 2 years.

In an official statement, **Mr. Pradeep Misra, CMD-REPL said**, "Improving the quality of education and focus on the healthcare infrastructure are two most important aspects for the development. Ensuring education and health infrastructure in tier 2 and 3 cities are extremely important to improve the living standard. The impact of such initiatives may not be directly quantifiable and measurable. However, it will have multiplier positive impact on socio-economic condition. We are determined to play a pivotal role in the infrastructure development of the states as well as the county."

Mr. Zulquer Nain, VP-Real Estate Advisory, REPL said "While working on innovative and schematic designs, we will be adhering to National Building Code, relevant IS codes and Local building bylaws. Since the states are vulnerable to natural calamities, we will also have to ensure minimum land disturbance and protect all existing vegetation to the fullest. We will incorporate all applicable national operational safety norms and principles of universal design to maximize accessibility of people."
